The following is submitted as supplemental information regarding IE Bulletin No. 80-06.

In the letter to Mr. James G. Keppler, NRC, from Mr. D. E. Gilberts, NSP, dated June 16, 1980, it was stated that:

"APRS valves will close upon manual reset of Channel A and B logic timers. If the initiation signal is present, the APRS valves will reopen after a 120 second time delay."

A commitment was made to make modifications prior to or during the 1981 refueling outage so that the APRS logic would meet the strictest interpretation of the Bulletin.

Further review of the APRS logic and informal communications with General Electric Company has determined that modifications to the APRS logic to remove the operator's ability to terminate a blowdown once it has commenced is not desirable. Therefore, no modifications will be made at this time.
