I explained in some detail how we would share the draft report with the Commission in October, why we were deferring public release of the draft SOARCA report to improve it before public release, and how development of the report aligned with other initiatives that were underway, such as development of a recommendation on whether to conduct a level III PRA and identification and assessment of policy issues associated with the SOARCA results and path forward. The Commissioner noted that he intends to participate in the briefing that Commissioner Magwood has requested on SOARCA in the near future. [Subsequent to the meeting, I passed the Commissioner's concern along to Brian Sheron and Bill Borchardt; we intend to send up a Commissioner Assistants note to clarify the staff's path forward following the Commissioner Assistants briefing].
