HEARING FROM NOVEMBER 6 TO NOVEMBER 12, 1974.


Following receipt of a telephonic communication today from counsel for the AEC Regulatory Staff respecting a change in circumstances involving the scheduling of witnesses of both the Staff and Minnesota Pollution Control Agency, advising a change in the date<sup>1/</sup> from November 6, to November 12, 1974, for the convening of the hearing in the above-identified proceeding, and being advised by Staff counsel that attorneys for the other parties have no objection, the Board has granted the postponement requested.
