There could be a tabular comparison of present and predicted effluent radionuclide concentrations, with Federal and State standards.

Transmission line environmental impacts do not appear to be included.

More adequate presentation of the (temperature) plume distribution could be given, from horizontal, vertical and seasonal perspectives.

For fish species temperature acclimation and tolerance curves for physiological parameters should be included.

Neither Table V-2 nor any other presents original or present alpha or beta counts.

What effect would the fog from cooling towers have on transpiration and other microclimate-sensitive life processes?
