By letter dated November 17, 2011, Duke Energy Carolinas, LLC (Duke) submitted the Physical Security Plan (PSP) for the William States Lee III (Lee) Nuclear Station Units 1 and 2, Rev. 2 as a revision to Part 8 of the combined license (COL) application. This letter provides a reviewer's guide to facilitate the NRC's review of the Lee PSP. Comments are added to the reviewer's guide text to highlight revisions which address open Confirmatory Items.
