Coley,

According to our Chapter 12 review of Rev 6 of your COLA, all RAIs are closed, but we have confirmatory issues still left for your latest April 26, 2011 response to RAI 12.02-20 (ML11119A076, U7-C-NINA-NRC-110070). Please note that this DOES NOT include our ongoing review of RAI 03.08.04-37 as it may relate to potential revisions necessary to Chapter 3, 11 and 12.

- For RAI 12.02-20, fix Tables 12B-1 and 12B-7 to make them identical to how they were presented in the final spent fuel pool RAI response (include missing title in 12B-1, and make information identical to the RAI response in both tables, unless you have a reason for changing it, in which case you need to explain).
