The reviewer indicated that the applicant addressed our concerns for these RAIs, but was unable to verify that they have been incorporated into Rev 2.

For example RAI 14.03.07-32 makes changes to ITAAC Table A.3-1, Items 2a and Items 2b.

FSAR Rev 2 includes changes to 2.a and makes further changes. Item 2.b is deleted.

After some study, it appears there are three items in the change list that apply to this RAI (page 1-12 of the ITAAC Section)

- COLA Part 10, Table A.3-1, ITAAC Items 2.a and 2.b have been revised to address the design bases for protection against internal and external flooding.
- Modified language of ITAAC 2.a and 2.b from "a report exists" to "inspection of."
- ITAAC were deleted because barriers, penetrations, and doors are not credited for safety function

Of course, the third one is not readily apparent because (i) 2.b is not identified as the deleted ITAAC and (ii) the first two describe how Item 2.b is changed so one does not look for a deletion.

I think that we need a teleconference for Luminant to explain how the markups were incorporated into FSAR rev 2 or why they weren't incorporated.
