2) Physical Description

This shipment will consist of 4 x 30B cylinders in sealed UX-30 overpacks containing a maximum of 6,160 kg uranium enriched to less than 5% weight of U-235. UN 2977 Radioactive material, Uranium hexafluoride, fissile (UF6).

3) Transportation and Route Schedule

The ocean transportation from Liverpool, England to Halifax, NS will be the responsibility of Atlantic Container Line. The inland transportation from Halifax, NS to AREVA NP/Richland, WA by road will be the responsibility of RSB LOGISTIC SERVICES, INC. Entry into the United States will occur at Sweetgrass, MT (Primary) or Champlain, NY or Houlton, ME (Secondary) on or about August 30, 2011.
