Dear Mr. Denham:

This refers to your license amendment request dated November 2, 2011. Enclosed with this letter is the amended license. **The amended license is written in accordance with current NRC policy and includes significant changes in the conditions of the license. Please be reminded that Condition 19.A. of the license requires you to ensure that any individual designated as the Radiation Safety Officer meets the qualifications and training requirements specified in NUREG 1556, Vol 1, Rev. 1. Additionally, Item 8 of the license specifies a maximum possession limit of each radioisotope authorized on the license. These limits are based on the information provided by Andrew Kincell of your staff on November 28, 2011, during my telephone conversation with him. You are required to request and receive an amendment to your license prior to acquiring licensed material in excess of these limits.**

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
