As required by 10 CFR 95.19(a), Louisiana Energy Services (LES), LLC (dba "UUSA") is to submit substantive changes to Information System Security Plans (ISSPs) to the Cognizant Security Authority (CSA) for review and approval. UUSA hereby submits a License Amendment Request (LAR 11-18) and requests that the NRC review and approve an amendment to the subject license. Reaccreditation is formally being requested for the following seven ISSPs at this time in accordance with the provisions of section 5 of the Master Site ISSP and the Department of Energy *Program Cyber Security Plan Version 2.0.* 

- 1. Master Plant Control and Core Systems (PCCS) Information System Security Plan, LES-ISSP-1.1
- 2. Plant Control and Core Systems (PCCS) Plant Control System (PCS) Local Control Centers (LLC) Information System Security Plan, LES-ISSP-1.1.1
- 3. Plant Control and Core Systems (PCCS) Plant Control System (PCS) Clients Information System Security Plan, LES-ISSP-1.1.2
- 4. Plant Control and Core Systems (PCCS) Plant Control System (PCS) Servers Information System Security Plan, LES-ISSP-1.1.3
- Plant Control and Core Systems (PCCS) Medium Frequency (MF) Drive & Centrifuge Monitoring System (CMS) Information System Security Plan, LES-ISSP-1.1.4
- 6. Plant Control and Core Systems (PCCS) Plant Control System (PCS) Mobile Rigs and Systems Information System Security Plan, LES-ISSP-1.1.5
- 7. Classified Plant Management (CPM) Network Information System Security Plan, LES-ISSP-1.2

Enclosure 1 provides the background, proposed change and basis for the revised LES ISSPs. Enclosure 2 provides the proposed revision of the LES ISSPs. Revision bars, strikethroughs and underlines were utilized to reflect the changes. Enclosure 3 provides a final copy of the complete ISSPs with changes incorporated.
