Enclosed is Amendment No. 02 renewing your NRC Material License No. 45-31371-01 in accordance with your request.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

In your correspondence to us dated May 17, 2011 you indicated that you wished to release for unrestricted use 1753 East Gings Road, Rushville, Indiana.

The NRC staff has reviewed your final status surveys. Based on its review, the staff has concluded that all licensable radioactive material has been removed from 1753 East Gings Road, Rushville, Indiana, and residual radioactive material attributable to licensed activities does not exceed current NRC criteria.

Based on these conclusions no further remediation or actions with respect to NRC regulated material is required for 1753 East Gings Road, Rushville, Indiana, and it is suitable for unrestricted use.

Please note that we removed License Condition No. 13. This condition is no longer needed since your license now has possession limits.

We also we updated your license by modifying License Condition Nos. 16 and 17 as they appeared in Amendment No. 01 and added License Condition Nos. 16 and 22. These changes should enhance your awareness of regulatory requirements and the radiation safety program elements in your license.

The removal and addition of the above License Conditions necessitated us to renumber subsequent License Conditions.



You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
