INFORMATION CONCERNING FINANCIAL ASSURANCE DOCUMENTS,
CONTROL NO. 575923

Dear Mr. Hudd:

This is in reference to your letter dated October 20, 2011 providing financial assurance for decommissioning for Nuclear Regulatory Commission License No. 06-01450-47. In order to continue our review, we need the following additional information:

The guidance for submitting Financial Assurance is stated in NUREG-1757, Volume 3, "Consolidated NMSS Decommissioning Guidance, Financial Assurance, Recordkeeping, and Timeliness." In the letter dated October 20, 2011, the submission of the Statement of Intent and the Certification of Financial Assurance was given in one document. These are normally submitted by licensee's as two documents as the certification is to "certify" that financial assurance (Statement of Intent) is in place. It is recommended that you resubmit these as two documents.

1. The Certification of Financial Assurance contained inaccurate statement about the material licensed by the University of Connecticut. The material listed was the amount that University of Connecticut is licensed to possess of **unsealed byproduct material with a half life greater than 120 days** licensed under 10 CFR Part 30. The list contained all of the material that required financial assurance but should be designated as such. Please resubmit the Certification of Financial Assurance with the license amounts requiring financial assurance listed. Please see page A-23 of NUREG-1757, Volume 3.
2. The Certification of Financial Assurance did not contain a statement that certified that financial assurance in the required amount had been obtained for the purpose of decommissioning as required by 10 CFR 30.35(b)(2).
3. The Statement of Intent did not contain the following items listed in Checklist 16-B on Page A-151 of NUREG-1757, Volume 3: description of authority of government entity to make the statement of intent; identification of State government licensee; and recitation

of authority for signatory to sign the statement of intent. In Checklist 16-A of on Page A-150 of NUREG-1757, Volume 3, and the submitted documentation did not contain the documentation verifying that the signatory is authorized to represent the licensee in providing the statement of intent. It is recommended that you follow closely the statement of intent model given on page A-152 of NUREG-1757, Volume 3. Please resubmit the Statement of Intent with the above attributes and additional information.
