Enclosed is Amendment No. 08 renewing your NRC Material License No. 24-20121-01 in accordance with your request. Note that the major changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

Please note that this amendment renews your license for a ten year period and your license will not expire until November 30, 2021.

Please note that we modified your license by updating Subitem No. 9.A as it appeared on the Corrected Copy of Amendment No. 07 issued April 7, 2011. The manufacturers' names "Kay-Ray" and "Ronan" were corrected with their current, complete names "Rosemont Kay-Ray/Sensall, Inc." and "Ronan Engineering Company."

We also updated Condition No. 12 by placing your Alternate Radiation Safety Officer designations on the NRC license document. Mark Nilges is authorized to act as the Primary Alternate Radiation Safety Officer (ARSO) and Randy Jones is authorized to act as the Secondary ARSO, in the physical absence of Justin Dent, the incumbent named RSO.

In addition, we updated Condition Nos. 11 and 13 as they appeared in the Corrected Copy of Amendment No. 07 and we added Condition Nos. 19, 20, 23, and 24. These changes consisted of reformatting your license to include standard license conditions that appeared to be missing from your license. Placing them on your license now should enhance your awareness of the radiation safety program elements in your license and our regulatory requirements.

At this time, I excluded one item from your renewal application dated May 17, 2011, as shown in Condition No. 21. The exclusion pertains to the accidental listing of your Ronan RLL-1 gauges in the renewal application. These gauges

had to be excluded because you obtained them under a general license administered through the manufacturer. Therefore they could not be listed on this specific license.

As a reminder for future reference, and until this correction is made when NUREG 1556 Vol. 4 is revised, we can no longer permit you to name your own Radiation Safety Officers (RSOs, ARSOs) internally. NRC must amend your license before you change RSOs. To change RSOs you should name the proposed RSO, provide evidence of appropriate training and experience with the fixed gauges and submit a signed and dated statement that the proposed RSO accepts the position and understands the duties and responsibilities associated with it. Your senior management representative should also sign this statement and delegate authority to the proposed RSO to operate your Radiation Safety Program.
