Mr. Baron,

Strata Energy, Inc. submitted a license application to recover uranium at the Ross site in Oshoto, Crook County. The application was accepted for detailed technical review on June 29, 2011. The technical review consists of two parts, a safety review and an environmental review. The environmental review will culminate in a supplemental environmental impact statement (SEIS), that will tier from the Generic Environmental Impact statement (GEIS) for In-Situ Leach Uranium Milling Facilities (NRC, 2009).

On Monday, August 22, 2011, members of the NRC environmental review team will be given a tour of the proposed site. You and your staff are invited to attend this tour, which will begin at 0800 at Strata's office in Oshoto. The tour should last several hours, depending upon the number of questions that are asked.

On Thursday, August 25, the NRC environmental team will be in Sundance, and would like to meet with you at your office. The purpose of this meeting is to go over the plan the NRC has for reviewing the environmental portion of the license application, answer any questions you may have regarding the proposed project, and inquire what information you may have that could enhance the SEIS that we are preparing.

We would like to meet with other county personnel, if possible (Morgan Ellsbury, Road and Bridge) together, if possible, in the afternoon (Aug 25). Please let me know if this is possible, as we need to plan other aspects of our trip.
