This email is in regard to the blowdown pipeline crossing at the Cross Florida Barge Canal. In keeping with our District's requirements for such crossings in navigable waters, which are not a Federal channel, as detailed in Regional General Permit SAJ-14 for sub-aqueous utility and transmission lines, the blowdown pipeline should be buried a minimum of 4' below the existing bottom contour; and backfill or bedding for the transmission line cannot change the preconstruction bottom contours. I will need a revised typical cross-section (Fig.8) showing a minimum of 4' burial depth. I need a side-view drawing showing project from shoreline to shoreline, water depths in relation to MHW and MLW, present bottom contour, pipeline, and burial depth. Also, signs should be installed at the shorelines warning of the utility line crossing. A note should be on the drawing that warning signs will be installed.
