Thank you for your follow-up email and for your thoughtful recommendations. The prayer is an excellent suggestion, and it definitely set the tone for our proceedings in September.

I am sure the NRC kept detailed notes on the consultation and that they will give them careful consideration. For our part, we are working to incorporate your comments and additional comments we receive into our own tribal outreach efforts.

I am glad you raised the question of "fracking", as it points out an opportunity for us to improve the presentation we are giving to tribal representatives. The Ross ISR project will not use fracking, and in fact, the underground injection control (UIC) permit will not allow us to inject fluids at fracture-inducing pressures. We will amend our presentation for the November 2 site walkover to make that clear.

Are you planning to join us again on November 2-3? If so, please let Mr. Bjornsen with the NRC know at your earliest convenience (alan.bjornsen@nrc.gov). As in September, Melanie will handle your reimbursement request and will make your room reservations as necessary.
