Suzanne,

Strata Energy, Inc. submitted a license application to recover uranium at the Ross site in Oshoto, Crook County. The application was accepted for detailed technical review on June 29, 2011. The technical review consists of two parts, a safety review and an environmental review. The environmental review will culminate in a supplemental environmental impact statement (SEIS), that will tier from the Generic Environmental Impact statement (GEIS) for In-Situ Leach Uranium Milling Facilities (NRC, 2009).

On Monday, August 22, 2011, members of the NRC environmental review team will be given a tour of the proposed site. You and your staff are invited to attend this tour, which will begin at 0800 at Strata's office in Oshoto. The tour should last several hours, depending upon the number of attendees and the questions that are asked.
