SUBJECT: GLOBAL NUCLEAR FUEL – AMERICA'S REQUEST TO RESCHEDULE  
INTEGRATED SAFETY ANALYSIS ACTION PLAN MILESTONES

Dear Mr. Murray:

This is in response to your letter SPM 11-066, dated November 29, 2011, which submitted a request to reschedule the Integrated Safety Analysis (ISA) Action Plan milestones as a result of increased scope discussed in meetings on September 30 and November 3, 2011.

The U.S Nuclear Regulatory Commission (NRC) evaluated the existing license condition required to document commitments related to the ISA Action Plan and found that it should be revised.

Pursuant to Part 70 to Title 10 of the *Code of Federal Regulations* (10 CFR), Safety Condition S-4 of Materials License SNM-1097 is amended as follows:

S-4: Global Nuclear Fuel – Americas (GNF-A) may continue to conduct license activities and maintain records in accordance with the approved SNM 1097, Revision 1 of Chapter 3, "Integrated Safety Analysis," and Revision 2 of Chapter 11, "Management Measures," subject to GNF-A's commitments in GNF-A's reply to Notice of Violation (EA-090268) dated July 23, 2010—including but not limited to: (1) its commitment regarding criticality control-related event reporting; and (2) until completion of the actions set forth in the Revised ISA Action Plan Schedule contained in the attachment to the November 29, 2011, letter.

Safety Condition S-1 has been revised to include the date November 29, 2011.

All other conditions of this license shall remain the same.

In accordance with 10 CFR 2.390(d) of the NRC's "Rules of Practice," a copy of this letter and Enclosures 1 and 3 will be available electronically for public inspection in the NRC Public Document Room or from the Agencywide Documents Access and Management Systems (ADAMS). ADAMS is accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html> (the Public Electronic Reading Room). Enclosure 2 will be withheld from the public in accordance with 10 CFR 2.390(b).
