Dear Ms. Simmons:

This amendment request is for consent to transfer control of our radioactive material license to the new owner, Fairview Heights Medical Group – BJC Medical Group Cardiology Specialists. The tax identification number is 36-4147189. The following address the items requested in Appendix F of NUREG-1556, Volume 15.

1. The private practice of Cardiology Specialist, P.C. was sold as an asset purchase agreement with an effective date of August 1, 2011. The practice had a name change and the new name is Fairview Heights Medical Group – BJC Medical Group Cardiology Specialists.
2. There are no planned changes in personnel or duties that relate to the licensed program. The Authorized Users and Radiation Safety Officer remain the same. The nuclear medicine technologist remains the same.
3. Mary Beth Dieckmann-Kirisits is the Manager of Fairview Heights Medical Group- BJC Medical Group Cardiology Specialists. There will be no change in location, facilities, equipment, or procedures that relate to our licensed program.
4. Tom Schlarman-Radiation Physicist- of Radioactive Protective Services did a complete evaluation of the licensed program. Survey and wipe test were conducted on 5/10/11 & 11/10/11. Sealed sources were leak tested with no detectable removable contamination on 5/10/11 & 11/10/11. Quality control testing records of the radiation safety instruments are on file. Required regulatory calibrations of the gm survey meter and does calibrator are current and on file. No problem with the program was noted.
5. We confirm that all records concerning the safe and effective decommissioning of the facility will be transferred to Fairview Heights Medial Group-BJC Medical Group Cardiology Specialists. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity. We only used short lived unsealed radioactive material (Tc-99m and Tl-201) in our practice.

6. We confirm that Fairview Heights Medical Group-BJC Medical Group Cardiology Specialists will abide by all constraints, conditions, requirements, and commitments of NRC license No. 24-32650-01.





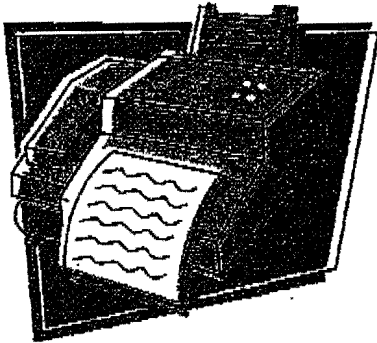
