- (1) Your request was received on August 29, 2011; yet the requesting letter is dated December 1, 2010. Please submit the letter with a new date, reflecting the date of submittal.
- (2) The Illinois license document submitted in support of this request (IL-2163-01) excludes possession and uses of generators. In order to add Dr. Azam for 35.200 authorization, you will need to provide additional supporting information as evidence of his meeting the requirements set out in 35.290 for the use of 35.200.
- (3) Please provide a signed letter from senior management of DIS confirm your authority to sign official documents on behalf of the licensee.
