• Purpose of Travel:	The purpose of the trip is to participate in the Multinational Design Evaluation Program (MDEP) meeting. The trip also includes a site visit to Olkiluoto 3, the world's first EPR design that is near completion.		

<ul style="list-style-type: none"> • Desired Outcome: 	<p>The desired outcome is information exchange regarding the design, licensing, and construction of EPR reactor design.</p>	
<ul style="list-style-type: none"> • Traveler Role(s): 	<p>John Segala, NRO (Branch Chief LB1), is responsible for overall EPR design centered activities. Mr. Segala and Mr. Colaccino will lead the discussion on EPR design centered activities.</p> <p>Getachew Tesfaye, NRO, is the lead project manager for EPR design certification project and the coordinator and point of contact for MDEP EPRWG. He will be presenting the design certification project status report at the meeting. Mr. Tesfaye will coordinate the meeting activities and will have the leading role in preparing the trip report.</p> <p>Joseph Colaccino, NRO (Branch Chief EMB), was the responsible for overall EPR design center activities until Dec 2011. Mr. Colaccino and Mr. Segala will lead the discussion of EPR design center activities.</p> <p>Terry Jackson (Branch Chief, ICE1)- Chair, MDEP EPR I&C Technical Expert Sub-Group (TESG). Purpose at the meeting is to coordinate discussions and activities of the EPR I&C TESG and communicate the TESG's accomplishments and plans to the EPR Working Group.</p> <p>George Wilson – Chief, NRR/DE/EICB. Purpose at the meeting is to (1) obtain insights on EPR I&C review by other regulators that may benefit operating reactor digital upgrade reviews, (2) understand aspects associated with harmonization of I&C regulatory reviews, (3) observe modern digital I&C installation at Olkiluoto 3 (non-safety I&C systems and control room simulator), and (4) network with other regulators involved with I&C reviews</p> <p>Jack Zhao – Senior Technical Reviewer. Purpose at the meeting is to present the NRC's review efforts and results regarding the U.S. EPR I&C design and gather information from other regulators regarding the EPR I&C review. He is also the lead for developing the technical report regarding the EPR I&C design, TESG activities, and commonalities/differences in regulatory reviews conducted.</p> <p>Edward Fuller, NRO - Severe Accident (SA) technical expert - as the EPR SA technical expert, Mr. Fuller will present the design and technical review activities of the U.S. EPR and gather similar technical information from the other regulatory bodies at the SA subgroup meeting.</p>
