Enclosed is Amendment No. 10 renewing your NRC Material License No. 24-26333-01 in accordance with your request.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

We also we updated your license by modifying License Condition Nos. 13, 15 and 16 as they appeared in Amendment No. 09 and added License Condition Nos. 18 and 19. These changes should enhance your awareness of regulatory requirements and the radiation safety program elements in your license.

The removal and addition of the above License Conditions necessitated us to renumber subsequent License Conditions.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system. Pursuant to NRC's RIS 2005-31 and in accordance with 10 Code of Federal Regulations 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability. 
