The Reference letter contains a schedule for submitting seven Final Status Survey ("FSS") Reports to the U.S. Nuclear Regulatory Commission ("NRC") for the decommissioning and license termination of the ABB/Combustion Engineering, Windsor, CT Site ("Site").

This letter submits the third FSS Report of seven for portions of the Site identified as the Burning Grounds, Woods Area, Drum Burial Pit, Clam Shell Pile and Building 2 Sanitary Waste Line. The Report was produced commensurate with the Site Decommissioning Plan. In doing so, ABB has complied with the decommissioning requirements set forth in 10 CFR 30.36 and 10 CFR 20, subpart E.
