Dear Mr. Kowalski:

Enclosed is Amendment No. 06 renewing your NRC Material License No. 21-18491-01 in accordance with your request. Note that the major changes made to your license are printed in **bold** font.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

**Please note that this amendment renews your license for a ten year period and your license will not expire until December 31, 2021.**

**Please note that we modified your license in that the current, correct name of your vendor is "Troxler Electronics Laboratories" and your renewed license has been reflects this in Subitem Nos. 9.A and 9.B.**

**Please note that we modified your license by updating Conditions No. 13, 18 and 19. These changes consisted of reformatting your license to include standard license conditions and completed sections of conditions that appeared to be missing from your license. Placing them on your license now should enhance your awareness of the radiation safety program elements in your license and our regulatory requirements.**

**At this time, we excluded one item from your renewal application dated June 3, 2011, as "tied-down" in Condition No. 20. The item concerns an error that exists in the NUREG 1556, Vol. 1, Rev. 1. This NUREG contains a few items that have changed since its publication but it has not been revised yet to reflect these changes.**

**Your response letter dated November 18, 2011, authorized you to "self-appoint" future Radiation Safety Officers (RSOs) who meet specified training and experience requirements.**

**We can no longer permit you to do this. NRC must amend your license before you change RSOs in the future. To change RSOs in the future you should name the proposed RSO, provide evidence of adequate and appropriate training and**

**experience with the portable gauges and submit a signed and dated statement that the proposed RSO accepts the position and understands the duties and responsibilities associated with it. Your senior management representative must also sign this statement and delegate authority to the proposed RSO to operate your Radiation Safety Program.**

In accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be available electronically for public inspection in the NRC Public Document Room or from the NRC's Agency wide Documents Access and Management System (ADAMS), accessible from the NRC Web site at <http://www.nrc.gov/reading-rm/adams.html>.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you.

This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
