 Troxler Electronic Laboratories Model No. 4640 (1 gauge) 9 mCi Cs-137
 Licensee requested one additional gauge be authorized for flexibility. 10 mCi Cs-137; 50 mCi Am-241

Total Cs-137 activity requested: 95 mCi
 Total Am-241 activity requested: 426 mCi

Mr. Chapek was informed that license condition 14.C and 19 will be removed from the license as they do not apply to the authorized devices. Mr. Chapek was informed that the license will be amended to include the maximum possession limits discussed above. He agreed with the possession limit.

Mr. Chapek also informed me that the licensee no longer uses the PO Box identified on the license. I requested that he send a letter requesting an amendment to remove the PO Box from the license.
