On August 17, 24-25 and September 19-20, 2011, John Nicholson of this office conducted a safety inspection at the ABB Inc, CE Windsor Site, 2000 Day Hill Road, Windsor, Connecticut of activities authorized by the above listed NRC licenses. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. Additional information provided in correspondence dated September 16, October 6, 27, and November 14, 2011 was also examined as part of the inspection. The findings of the inspection were discussed with you in a telephone exit meeting on December 21, 2011. The enclosed report presents the results of this inspection.

Within the scope of this inspection, no violations were identified.
