Dear Mr. Goddard:

This refers to the administrative license amendment discussed with your Radiation Safety Officer, Matthew Chapek, via telephone. In accordance with current NRC policy, this license amendment was necessary to provide maximum possession limits for the material your license authorizes. Enclosed with this letter is the amended license.

The maximum possession limits were discussed with Mr Chapek during a telephone conversation with Scott Wilson of this office on December 12, 2011. The license was amended to include the maximum possession limits, a change to your business address as described in the letter of request you submitted to this office by facsimile on December 23, 2011, and to remove previous license condition numbers 14.C and 19 (A & B) did not apply to the material authorized by your license.

Prior to acquiring additional devices or radioisotopes not already authorized by your license, a license amendment must be requested and authorized by NRC.

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
