Enclosed is Amendment No. 56 to your NRC Material License No. 24-01570-03 in accordance with your request. Please note that the major changes made to your license are printed in **bold font**.

As discussed in our telephone conversation on December 16, 2011, the information provided was not sufficient to authorize Dr. Bhatt for 10 CFR 35.300, 35.400 and 35.600 (remote afterloader units) materials and uses, as requested. Should you wish to pursue adding Dr. Bhatt to the license in the future, please review 10 CFR 35.390(b), 35.490(b), and 35.690(b), as well as NUREG 1556, Vol. 9, Rev. 2, Appendix D for the specific requirements and documentation needed for submittal to the NRC, and provide the information discussed.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

NRC's Regulatory Issue Summary (RIS) 2005-31 provides criteria to identify security-related sensitive information and guidance for handling and marking of such documents. This ensures that potentially sensitive information is not made publicly available through ADAMS, the NRC's electronic document system. Pursuant to NRC's RIS 2005-31 and in accordance with 10 Code of Federal Regulations 2.390, the enclosed license document is exempt from public disclosure because its disclosure to unauthorized individuals could present a security vulnerability. 
