Dear Mr. Kaminskas:

On February 21, 2012, the NRC will begin the temporary instruction (TI) inspection, "Review of Implementation of the Industry Initiative to Control Degradation of Underground Piping and Tanks," (TI 2515-182) at your Perry Nuclear Power Station. This on-site inspection is scheduled to be performed February 21 – 23, 2012.

In order to minimize the impact to your on-site resources, and to ensure a productive inspection for both sides, we have enclosed a list of documents pertinent to our inspection. The documents that are requested for this inspection include all relevant documents that will allow the inspector(s) to adequately complete Phase 1 of this inspection.
