2) Physical Description

This shipment will consist of 337 drums of Uranium Ore Concentrate (U-308) in 7 x 20' ocean containers. The total weight of the shipment is 133,816.788 kg of U-308.

3) Transportation and Route Schedule

The vessel sails from Adelaide on August 15, 2011. The ocean transportation from Adelaide to Oakland, CA USA will be the responsibility of Hamburg Sued. The vessel will unload at Oakland, CA USA on or about September 06, 2011. Shipment will be reloaded onto another Hamburg Sued vessel at Oakland, CA USA on or about September 08, 2011.
