REQUEST TO TERMINATE LICENSE SNM-1067, CONTROL NO. 576602

Dear Mr. Conant:

This is in reference to your letter dated December 21, 2011, requesting to terminate Nuclear Regulatory Commission License No. SNM-1067. In order to continue our review, we need the following additional information:

There appears to be an inconsistency in your December 21, 2011, correspondence requesting license termination of your SNM-1067 license for your site in Windsor, Connecticut. In your cover letter you state that no licensed material possessed under this license is on site. However, on the NRC Form 314 accompanying your letter, you checked the box that all radioactive material possessed under your SNM license has been transferred to your NRC broad scope license 06-00217-06. This license is also for your site in Windsor, Connecticut. Based on completed inspections at the Windsor, Connecticut site in 2011, we also understand that you have disposed of waste generated during site decommissioning at a licensed radioactive waste disposal site. Please clarify the information provided in the cover letter and the NRC Form 314 so that the information is consistent between the two documents and also reflects our understanding of the previous disposal of radioactive waste from the ABB Inc. Windsor, Connecticut site.
