The implementation schedule is currently under development and will be contained in a subsequent revision to be submitted in accordance with the original commitment date made in the April 14, 1983 Duke response.

Additionally, in accordance with the original commitment date, Revision 3 also contains the Oconee SPDS Safety Analysis.
