2) Physical Description

This shipment will consist of 4 cylinders of Uranium Hexafluoride (UF6) in sealed overpacks. The cylinders are 30B cylinders containing 6,160 kg Uranium enriched to less than 5% weight of U-235. UN2977, Radioactive Material, Uranium Hexafluoride, Fissile

3) Transportation and Route Schedule

The ocean transportation from Antwerp, Belgium to Baltimore, MD will be the responsibility of Atlantic Container Line.
