OE and OI had no changes to the list of items coming to the Commission. RES had the following changes:

- SOARCA (200700117/200800373) – RES suggested this be edited to indicate this item will be a priority to August, rather than July. Also, the current list identifies a potential Commission meeting in June. Based on the extension request, the SECY paper isn't due to the Commission until July 7, so the Commission meeting should be July or August. Also, SOARCA is on the list twice – once in October 2010 and once in July 2011. I think the October entry should be deleted (unless it's standard practice to track items with extensions twice).
- Outside of Scope
- Level 3 PRA (201000119) – RES submitted an extension request so that the due date of this paper would align with the SOARCA paper (due to the Commission on July 7, 2011). The extension request was approved by OEDO on October 29. The current line for this item indicates it's for a potential Commission meeting in February. This should be revised to indicate the potential Commission meeting is in July or August (like SOARCA).

I hope that's all you need for this. RES tried to mark up the Excel spreadsheet, but it was a little hard to follow and I thought this would be easier. If you'd prefer getting updates that way, let me know and I'll try to sort it out.
