Dear Gerald or FOIA Officer:

Please treat this email as two separate FOIA requests.

Attached to this email is a May 20, 2009 letter from Duke Energy to the US NRC which is publically available in ADAMS as ML091470265. In the letter there are six documents referenced which I request pursuant to the federal Freedom of Information Act, 5 U.S.C. §552. Please see the attached markup. The six items are:

- (1) Nuclear Regulatory Commission letter dated August 15, 2008 related to external flooding at Oconee Nuclear Station, Units 1, 2, and 3
- (2) Duke Energy Carolinas' September 26, 2008 response to the August 15, 2008 NRC letter.
- (3) NRC Letter from Joseph G. Giitter to Dave Baxter dated April 30, 2009 evaluating the September 26, 2008 response.
- (4) The information which Duke presented at its May 11, 2009 at NRC headquarters with FERC, NRR, Region II and others. At this meeting, Duke presented information related to inundation studies involving a postulated failure of the Jocassee Dam and potential flooding at the Oconee Nuclear Station. I would like all the information presented by Duke at this meeting.
- (5) The interim response which Duke was assigned to provide within 30 days from May 11, 2009.
- (6) The final response which Duke was assigned to provide within 60 days from May 11, 2009.

Please provide the four documents mentioned above. If convenient for the NRC, all four documents can be assigned to the same FOIA request. I would like to receive the information in electronic format; preferably by the NRC publically releasing them into ADAMS. If any of the above six items are already publically available in ADAMS, please provide me the Main Library numbers for those items.

As a separate FOIA request, I request the following information pursuant to the federal Freedom of Information Act, 5 U.S.C. §552:

All correspondence between Duke Energy and the US NRC regarding Jocassee Dam from August 15, 2008 to the present, excluding the documents already requested above.

Since this second FOIA request might require a search for records, I do not wish it included with the first FOIA request. That is, I do not wish the release of the six items requested above to be delayed by the NRC searching for additional records. I want the six items requested above released as quickly as possible since these documents should be readily retrievable by the NRC staff.
