In the “Closure Plan for U.S. EPR Fuel Assembly Design Topical Report, ANP-10285P”, which was submitted via AREVA NP letter NRC:11:103 dated September 22, 2011, AREVA NP provided final response dates for the seventh round of request for additional information (RAI). In a subsequent e-mail on November 23, 2011, AREVA provided revised FINAL response dates for RAI-64, RAI-65 and RAI -66 based on the audit conducted in our Lynchburg, VA office on November 17 – 18, 2011.
