Dear Mr. Stout:

This concerns the subject application for an amendment to your material license. This amendment request deals with a major revision to your Radiation Safety Manual. In accordance with NRC Confirmatory Action Letter (CAL) 1-11-001, dated October 20, 2011, it was agreed that you would obtain the services of a third-party to independently assess your submission. As noted in our letter dated December 22, 2011, we requested additional information from you in the next 30 days in order to proceed with our review. Your submission provided an overview, but did not include your step-by-step operating and emergency procedures as required by the CAL and our letter dated December 22, 2011. During a conference call on January 25, 2012, with Kathy Modes, of my staff, she informed you that your December 9, 2011 license amendment was not adequate and reviewed the December 22, 2011 letter and the CAL commitments. Both of you agreed that in order to provide a complete comprehensive response, you would need additional time. Because you informed us that you will not be able to supply the additional information required to complete the requested action within a reasonable amount of time, we have voided your application. This action is taken without prejudice to the resubmission of your request.
