In regards to more information of the device numbers 100/1, 100/2, 100/3, 100/4, and 100/5, upon reviewing our records, we also cannot determine how these came to be included under license condition 10. Hess Fine Arts has never and does not currently distribute any "luminous timepieces" manufactured by mb-microtec. All timepiece models distributed by Hess Fine Arts are manufactured by BALL Watch Company SA as listed in our Registry (No. NR-1265-D-101-E). mb-microtec is the supplier of the sealed sources used in the manufacture of BALL Watches.
