Dear Mr. Abrams:

This refers to your license amendment request dated January 26, 2012. Enclosed with this letter is the amended license. In addition to your new facility, Condition 10 also includes your current facility as an authorized location of storage and use. This is to enable you to move your licensed activities to the new facility. After you have moved all licensed material to your new facility, you must request and receive an amendment to your license to remove the current facility from your license prior to releasing the facility for unrestricted use. You must include documentation that demonstrates that the facility is free of any residual radioactive contamination, and please refer to the Control Number at the top of this letter.

Please note that the amended license is written in accordance with current NRC policy and includes significant changes to the conditions of the license. Condition 13 and 19 that appear in the previous version are deleted from the amended license because they are not applicable, and Condition 11 is revised. Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region I Office, Licensing Assistance Team, (610) 337-5239, so that we can provide appropriate corrections and answers.

An environmental assessment for this action is not required, since this action is categorically excluded under 10 CFR 51.22(c)(14).
