In accordance with the provisions of 10 CFR 110.31, FirstEnergy Nuclear Operating Company (FENOC) is submitting a request to the Nuclear Regulatory Commission (NRC) for an application for a specific license to export nuclear equipment. Attached is the NRC Form 7, "Application for NRC Export or Import License, Amendment, Renewal, or Consent Request(s)," for the request.

FENOC purchased a steel forging for conversion into a reactor vessel closure head for the Beaver Valley Power Station, Unit No. 2. The forging was manufactured in Japan by the Japan Steel Works, Ltd. The forging was shipped to and stored in the United States pending the selection of the vendor to fabricate the closure head. The vendor has been selected and the work will be performed at ENSA Equipos Nucleares which is located in Spain. Shipment of the forging from the United States to Spain necessitates the specific license for export.

FENOC requests approval of the application by March 1, 2012 to support shipment of the forging to ENSA Equipos Nucleares for fabrication. The finished reactor vessel closure head later will be returned for end-use in the United States pursuant to the general license to import major components provided for in 10 CFR 110.27(e).
