This refers to your license amendment request dated January 26, 2012. Enclosed with this letter is the amended license. **Please note that the amended license is written in accordance with current NRC policy and includes significant changes to the conditions of the license. Specifically, Condition 11 is revised and Condition 18 that appears in the prior amendments of the license is deleted because it is not applicable to the gauges authorized on the license. The amended license authorizes you to possess a maximum of five Troxler Models 3400 series and 3411.**

Please review the enclosed document carefully and be sure that you understand and fully implement all the conditions incorporated into the amended license.
