Accordingly, the following specific changes are to be made to the Contract:

1. **Section B.5, DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987)**, delete in its entirety and replace with the following,

"The ordering period for this contract shall commence on March 11, 2012 and will expire March 10, 2013".

2. **Section F.2, DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988)**, delete in its entirety and replace with the following,

"The ordering period for this contract shall commence on March 11, 2012 and will expire March 10, 2013. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 – Ordering.) The term of this contract may be extended at the option of the Government for an additional TWO 1-YEAR OPTIONS."
