2) Physical Description

This shipment will consist of 4 x 30B "Heeled" Cylinders in sealed overpacks on 1 x 20' flatrack containing 27 kg of Uranium. RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, FISSILE (HEELS)

3) Transportation and Route Schedule

The surface transportation from Richland, WA to Baltimore, MD will be the responsibility of RSB LOGISTIC SERVICES INC.
