This shipment consists of 8 x 48Y Cylinders loaded on 8 x 20' flatracks. RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, non fissile or fissile-excepted. Total net weight of U is 65,800 kgs. The net weight of U-235 is 472 kgs.


