Enclosed for your information is the *Federal Register* notice for a final rule amending 10 CFR Parts 19, 20, and 50. The Nuclear Regulatory Commission (NRC) sent the Office of the Federal Register this final rule which amends the requirements for the reporting of annual dose to workers, the definition of the total effective dose equivalent (TEDE), the labeling of containers holding licensed material, and the determination of cumulative occupational radiation dose.

In § 19.13(b), the reporting of annual doses to workers will be limited to those whose annual dose exceeds the dose threshold of 1 mSv (100 mrem) for providing instructions to workers. This will result in the elimination of an unnecessary reporting burden. In §§ 20.1003 and 50.02 the definition of TEDE will be revised to be consistent with current Commission policy. Under the revision to § 20.1905, nuclear power licensees will not be required to label containers holding licensed material located in a posted area, if they are conspicuously marked and their accessibility is limited. Finally, the requirement in § 20.2104(a) that licensees attempt to obtain the records of a worker's cumulative occupational radiation dose will be removed.

These revisions will reduce administrative and paperwork burdens on NRC licensees without affecting the level of protection to either the health and safety of workers and the public or the environment.
