SUBJECT: REQUEST FOR RESPONSE TO MULTIPLE ATTEMPTS TO CONTACT YOU
AND CONDUCT AN NRC INSPECTION

Dear Ms. Rabara:

This refers to your License No. 21-32673-01 issued by the Nuclear Regulatory Commission (NRC) that authorizes byproduct material use for diagnostic imaging at temporary job sites. We have attempted to conduct an inspection of your activities authorized at the address referenced above, but have been unable to contact you. Discussions with your consulting physicist, who also serves as your Radiation Safety Officer (RSO), indicated that he could not contact you.

As we described in our email dated February 2, 2012, our office has attempted to conduct an inspection during September 2011, October 2011, and on January 24, 2012. We have visited the authorized storage location listed on your license and found that to be a UPS Store. The UPS Store representative clarified for us that the address on your license may be incorrect because the Suite Number listed in item 2 should actually list a Post Office Box Number. The imaging vehicle could not be located at your authorized location as referenced on your NRC license. We have placed calls to you and left voice mail messages on your personal cellular telephone, however we have not been able to contact you. Although you responded to our February 2, 2012, email informing us that you are no longer in business, our attempts to contact you for additional information and guidance on the licensing process have been unsuccessful.

Please be advised that Title 10 of the Code of Federal Regulations (CFR) Part 19.14 requires that each licensee afford to the Commission the opportunity to inspect materials, activities, facilities, and records related to your NRC license. Please note that the materials possessed under your NRC license must be properly secured in accordance with the terms and conditions
