We have received Chapter 3 from the contractor (see attached) and are now ready to begin the concurrence portion of the SER process for Phase 2. The chapter day meeting is scheduled for **9:00 am on Friday, July 17, 2009**. Please be prepared to share any comments or discuss any issues that you may have at this time. The success of this process is dependent upon the preparation and attendance of everyone who needs to concur on the North Anna SER for **Chapter 3**. Our goal is to conclude the meeting with concurrence from OGC, the technical branch chief(s), LA, and PMs.

ADDITIONAL INFO:

I have a several items to discuss in order to help facilitate the Chapter Day.

- I have created an **input matrix** by section with branch inputs. Please let me know ASAP if you have any discrepancies.
- In order to not keep people around for the entire meeting, we will review and concur on **minimal branch inputs for this chapter first** and more involved branch inputs later during the meeting, i.e., EMB2 will attend entire meeting. I will formalize a list for this closer to Chapter Day.
- If you simply wish to give me an **email concurrence** for your sections, then let me know ASAP. Please note that we also need **BC concurrence**.
- Before the meeting, please have your **sign off authorities** arranged and let me know what they are.
