SUMMARY OF PUBLIC FORUMS TO DISCUSS THE FINAL RULE ON ENHANCEMENTS TO EMERGENCY PREPAREDNESS REGULATIONS AND ASSOCIATED GUIDANCE

In 2011, the U.S. Nuclear Regulatory Commission (NRC) issued the final rule regarding enhancements to emergency preparedness (EP) regulations. The EP final rule was published in the *Federal Register* on November 23, 2011 (76 FR 72560), with an effective date of December 23, 2011. The NRC and Federal Emergency Management Agency (FEMA) also issued several guidance documents associated with the EP final rule. The EP final rule and associated guidance documents can be found at www.regulations.gov under Docket ID NRC-2008-0122.

The NRC, in conjunction with FEMA, held a series of public meetings (forums) related to the EP final rule and associated guidance (see Enclosure 2 for dates, times, and locations). The purposes of these forums were to: 1) provide NRC and FEMA expectations for implementing the revised EP regulations and guidance in accordance with various due dates; 2) answer questions from licensee and offsite response organization stakeholders about implementation of the EP final rule and onsite/offsite EP guidance changes; 3) provide an overview of changes to the NRC inspection procedures regarding the revised EP regulations; and 4) provide opportunities for members of the public to observe and ask questions about the EP final rule and guidance.

For these sessions, the attendees had different options to participate in each forum: attending the forum in person; by telephone; or through web conferencing (for the first and last sessions only). Including all sessions, over 550 people attended the forums, 64 registered for web conferencing, and several more requested access by phone (see Enclosure 3 for a list of attendees).

The first portion of each agenda item regarding the EP final rule and guidance changes was led by representatives from the NRC and FEMA, who presented an overview of the EP final rule changes and associated guidance documents, actions and deliverables licensees and offsite response organizations were expected to address, implementation due dates, and pending NRC inspection procedure changes. After the NRC and FEMA staff completed their presentations, the floor was opened for questions from the forum attendees representing NRC licensees, and State, local and tribal response organizations. The attendees asked questions to clarify the EP rule changes, guidance changes, implementation activities, and implementation timeframes. Attendees not affiliated with a licensee or offsite response organization were permitted to ask questions of the panel at designated times in the agenda. Responses were provided by the panel of NRC and FEMA staff.

Based on the conduct of the first two forums in Rockville, MD and Portsmouth, NH, the last three forums were shortened to a two-day time period (instead of two and one-half days) while addressing the original forum topics and maintaining opportunities for public participation. Amended meeting notices and agendas were issued. The final NRC-FEMA slide presentation and presentation booklet are available on www.regulations.gov, as well as in ADAMS under ADAMS Accession Nos. ML113270034 and ML113420437 respectively. A complete listing of documents related to the forums is provided in Enclosure 4. These meetings were not transcribed.
