After the date of the merger between Duke Energy and Progress Energy, the applicant for Levy Nuclear Plant, Units 1 and 2, should state whether the COL application is affected by the merger, and, if applicable, state the changes that occurred based on the merger. Pursuant to 10 CFR §§ 52.77, 50.33, 50.38, and Part 50 Appendix C, the following information should be provided to the NRC:

- 1) The applicant name;
- 2) Names, addresses, and nationality of the directors and officers of the parent company;
- 3) If the applicant is owned, controlled, or dominated by an alien, a foreign corporation, or foreign government, including by any international business arrangements;
- 4) The organizational structure of the company from parent to applicant;
- 5) Construction cost estimate;
- 6) Sources of construction funds;
- 7) Latest published annual report, together with any current interim financial statements that are pertinent;
- 8) If the applicant is a newly formed entity; AND
- 9) If the applicant is an electric utility.
