**SUMMARY**

We have conducted a preliminary review your license amendment request and find that we are unable to continue this action until we have received information regarding the following:

1. For each AU requesting a 10 CFR 35.200 authorization, a preceptor attestation is required under 10 CFR 35.290(c)(2). To add the proposed 5 new Board Certified AUs –Chad Allen Link, Richard Michael Pinke, Joni R. Summit, Matthew D. Wilcox, and Peter J. Yoo, D.O.'s – please submit completed forms 313A (AUD), including the required preceptor attestations, for each requested AU.

**RESPONSE: Preceptor attestations for Drs. Link, Pinke, and Summit, were included in completed NRC 313A (AUD) forms, attached to a letter dated February 7, 2012, and were submitted via facsimile on February 24, 2012. Statements were not included for Drs. Wilcox and Yoo, per Item 2, below. No additional information is required.**

2. The request to add Authorized Users included Matthew D. Wilcox, and Peter J. Yoo, D.O.'s. However, copies of these physicians' Board Certifications were omitted from the request. For Drs. Wilcox and Yoo, please provide copies of their 2010 and 2002 Board Certifications, respectively. Alternatively, you may submit letters from the CBNC, indicating the exact language on the Board Certifications.

**RESPONSE: In the letter dated February 7, 2012, submitted via facsimile on February 24, 2012, the licensee withdrew the request to add Drs. Wilcox and Yoo. No additional information is required.**
